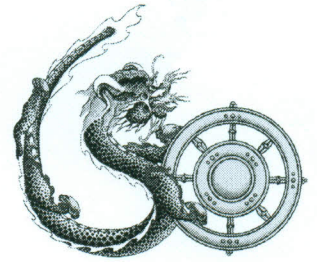

Subject: Notification on Relieving of Accounts Personnel on Transfer

Dasho/Sir/Madam (s)

This is with reference to notification issued by Ministry of Finance vide DNB/R-Notification/2014-15/553 dated 5th December 2014 regarding relieving of civil servants on transfer. As per the notification, the civil servants who are transferred should be relieved within 30 days from the effective date of transfer. In case of non-compliance with transfer order, all the budgetary bodies are required to stop the payment of salary to the civil servant on transfer.

In view of above, the concerned agencies are requested to comply with the above mentioned notification and take necessary actions against unaffected transfer of Accounts Personnel at the earliest. Kindly find attached herewith a copy of unaffected transfer list of Accounts Personnel for reference and necessary actions.

The above notification is issued as per the decision of 92nd HR Committee Meeting held on 18th March 2015, Ministry of Finance.
