Important Note:

The RCSC vide letter no. RCSC/LTD/1/COM/2024/735 has granted an exception for civil servants at P2 who received a "Very Good" rating in both performance and potential for FY 2023-2024, allowing them to apply for P1 M positions even if their previous year's rating was "Good." This waiver is valid until the moderation deadline for FY 2024-2025 is completed.

Those applicants who have applied previously need not have to apply again as the HRD will verify the rating for the FY 2023-2024.

However, all the interested eligible in-service candidates serving at P2A who have not applied before fulfilling the minimum qualification requirement and fulfilling the other eligibility criteria as per Section 11.7.3 of BCSR 2023 may apply for the above posts. The candidates shall submit their application to the HRD, MoF on or before September 20, 2024 via online application form:
