Terms and Conditions

1. All the bidders shall pay Nu.300/ (Nu. Three Hundred) only, as entrance fee, which shall be non-refundable.
2. Any representative/s can register and avail a token on behalf of the interested bidder/s.
3. The bidder shall not be allowed to bid in the auction without a token number duly issued by RRCCO
4. The prospective bidders are mandated to inspect the lot/s before the Public Auction, therefore, the bid offered is at their liberty and judgment. No Complaint will be entertained at the later date.
5. The auction committee reserves the right to accept the bid on the spot or at any subsequent date. In case of any dispute or problems concerning the auction, the decision of the committee shall be final and binding.
6. The goods shall be offered to the highest bid. In case, the highest bid surrenders the bid value, the auction shall be awarded to the second highest bidder.
7. The top most winning bidder, whose bids are accepted, shall deposit a spot payment of 50% (in cash or Mbob) against the auction value at the fall of the hammer.
8. The balance 50% of the auction value shall be paid within 5 (FIVE) working days from the day of auction before 3 pm.
9. The highest bidder whose bid is accepted by the committee shall lift the goods at his/her own cost within 5 working days from the day of auction upon full payment.
