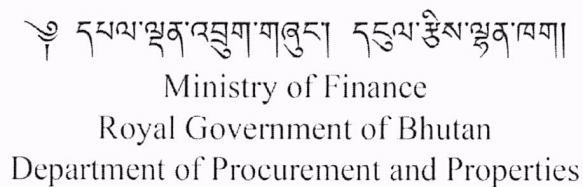

**Terms and Conditions**

1. Each bidder shall deposit the performance security of Nu.5,000.00 (Ngultrum Five Thousand only) in cash which is refundable to qualify him/herself to bid for the auction. On receipt of the performance security, a token shall be issued to identify the qualified bidder. The token issuance shall be available from **9th till 15th September, 2026 during office hours**.
2. All the bidder shall pay Nu. 300.00 (Three hundred only), as entrance fee, which shall be non-refundable. A person without a token shall be denied entry during the auction. Refreshment shall be provided to the participants.
3. Any representative can register and avail a token on behalf of the interested bidders.
4. All prospective bidders are advised to inspect the lots prior to the auction. However, inspection on the same day of auction shall not be allowed.
5. The performance security of the winning bidders shall be retained until the auction is completed as security for subsequent bids to be offered in respect to the remaining items. On completion of the auction, the performance security of the winning bidder shall be adjusted against the auction value of items won by the respective bidder. However, the performance security of unsuccessful bidders shall be refunded on the same day only upon completion of the public auction.

6. The Department reserves the right to withdraw, modify, defer, or cancel any lot at any stage prior to or during the auction. The Department shall not be liable for any claims or objections arising from such withdrawal, modification, deferment, or cancellation of lots. However, the Department shall provide valid justification for such actions.
7. The winning bidder, if Bhutanese, shall make a spot payment of 25% of the auction value through the mobile banking services immediately upon the fall of the hammer. However, if the successful bidder is non-Bhutanese, he/she shall make a spot payment of 25% of the auction value in cash immediately upon the fall of the hammer.
8. The remaining 75% of the auction value shall be settled within ten (10) working days from the date of the auction, on or before 4:00 PM. The winning bidder shall make the payment to the Department of Procurement and Properties. Failure to settle the payment within the stipulated timeframe shall result in cancellation of the accepted bid, and the deposited 25% of the auction value paid shall be forfeited, and the same lot(s) shall be listed for disposal in the subsequent auction.
9. The winning bidder whose bid is accepted by the committee shall take delivery/lift the vehicle or other properties at his/her own cost within 10 (TEN) working days from the date of the auction upon full payment. The winning bidder upon failure to lift the lot/s after the final payment, a demurrage charge of Nu.500 shall be imposed on every lot.
10. The transfer of ownership for a vehicle shall be completed within 15 days from the date of issue of ownership certificate. The buyer shall be levied 1% transfer tax for vehicles sold through auction. The transfer tax shall be paid to the BCTA at the time to proceed with ownership transfer in addition to other taxes levied by BCTA. A copy of ownership transfer certificate shall be duly shared with BCTA and the concerned agencies.
11. The bid offered is at the bidder's own liberty and judgment. No complaint will be entertained at a later date.
12. All registration number plates of the government vehicle sold through public auction shall be removed upon taking delivery by winning
13. All national bidders are required to attend the auction in national dress, while international bidders must attend in formal business attire. Failure to comply with this requirement may result in disqualification from participation in the auction.
14. Disposal of items through public auction shall be subject to GST as per the Goods and Service Tax Act and Rules. The bid value quoted by the successful bidder shall be inclusive of applicable GST, and no separate GST shall be charged during settlement.
15. The auction committee reserves the right to accept the bid on the spot or at any subsequent date. In case of any dispute or problem with regard to the auction, the decision of the committee shall be final and binding.
